The master's program in Middle Childhood provides specialized preparation for teaching at the middle level, in line with program standards of the National Middle School Association (NMSA) and Ohio Department of Education Academic Content Standards.

Selective Admission and Retention and the Program of Study

Applications for admission to the master's program in Middle Childhood may be completed and submitted online, at www.ohio.edu/graduate. Questions about application processes, materials and criteria for admission may be directed to Office of Student Services, 124 McCracken Hall, 740-593-4400. Requirements for retention in the program include: completion of all required professional education courses with a grade of B or higher in each, an overall grade-point-average of B or better, and a grade-point-average of 2.75 in each teaching field content specialization. Eligibility for the teaching license requires successful performance on each of three sections of the PRAXIS II examination: Principles of Learning and Teaching (PLT) and one content exam for each of the two teaching field content specializations.

Planning the Program of Study

A faculty advisor will be assigned at point of admission to the master's program, with contact information noted in the letter of recommendation for admission. Coursework recommended for initial quarters of enrollment include EDTE 510, 510L, 560, EDSP 570, EDCS 500, 501, 503 or 504, and EDCT 501, combined with any required teaching field content courses that have not already been completed at the undergraduate level. At the student's request, the undergraduate transcript(s) will be evaluated by the assigned faculty advisor to determine which of the content specialization requirements, if any, are satisfied by coursework successfully completed prior to admission to the Middle Childhood Program. With assistance of the faculty advisor, the student will submit an individualized Program of Study for review and approval at Program and Department levels, prior to completion of the first 20 credits at the graduate level.

Admission to Professional Standing, Early Field Experiences and Professional Internship

Admission to Graduate Professional Standing is a pre-requisite for beginning any clinical field classroom experience -- for tutoring, practicum, methods of teaching, or internship. Application forms are available at the Office of Student Services, 124 McCracken Hall. Students must also apply for Professional Internship. Applications for Professional Internship are due by December 1, at least one full year before the year you wish to be assigned a classroom placement for Professional Internship. Application forms are available online, or at the Office of Professional Internship, 138 McCracken Hall.

Eligibility for an Ohio Teaching License in Middle Childhood

In addition to completion of coursework requirements, eligibility for the Ohio teaching license in Middle Childhood requires successful score performance on three PRAXIS II examinations: Principles of Learning and Teaching (PLT) and content exams for each of the two teaching field content specializations. PRAXIS II examinations may be taken prior to or during Professional Internship PRAXIS II score reports must be received by Office of Professional Internship prior to graduation. - c) PRAXIS II examinations include one in each teaching field content specialization and a third in Principles of Learning and Teaching (PLT);
- d) PRAXIS II examinations should be taken prior to Professional Internship;
